Local Rules & Information

TEES: All play will be from the Black tees (approx: 6638 yards).
SPOTS: Qualifiers: 13 Alternates: 3
TIES: In the event of a tie for the last qualifying spot and/or the alternate spot, an announcement will be made as to the playoff procedure.
RULES: The Rules of Golf, the MGA Terms of Competition, Pace of Play Policy and the following local rules govern play.
FORMAT: Two 9-hole rounds, stroke play.
RULES TO NOTE: 4.3a(1) Distance and Directional Information. 10.2b(4) Restriction on Caddie Standing Behind Player. 12.2a Removing Loose Impediments and Movable Obstructions in Bunker. 13.1c Improvements Allowed on Putting Green. 13.2 No Penalty for Striking the Flagstick. 14.3 Dropping Ball in Relief Area.
OUT OF BOUNDS: Course boundaries are defined by the following: White stake or lines and property fences.
PENALTY AREAS: Penalty Areas are defined by either RED or YELLOW stakes and/or lines.
DROPPING ZONE: Local Rule E-1.1 There are no dropping zones in effect for this event.
GROUND UNDER REPAIR: In addition to areas circled by white lines, the following areas are ground under repair:
NO PLAY ZONE: All cultivated flower & shrubbery beds - mandatory relief
OBSTRUCTIONS: All artificially surfaced roads and paths including gravel and rock surfaced paths and roads and reasonable extensions thereof including their artificial borders.
PACE OF PLAY: The published MGA Pace of Play Policy is in effect.
