QUALIFYING MEMORANDUM TO PLAYERS

FORMAT/QUALIFYING PLACES: The field of contestants will play 18-holes, stroke play, and compete for **5** qualifying places and two alternate positions in the Sectional Qualifying for the 74th United States Junior Amateur Golf Championship to be played July 25-30 at Bandon Dunes Golf Resort, Bandon, Ore.

STARTING TIMES: Will be posted on the Qualifying webpage shortly after the deadline passes.

PLAYOFF: In the event of a tie, there will be a hole-by-hole playoff to determine the qualifier and the 1st and 2nd alternate if necessary. All announcements regarding the play-off will be made near the scoring area upon completion of the qualifying round.

ELECTRONIC SCORING: The official method of scoring will be electronic by use of the **Golf Genius Mobile App**. Paper scorecards will not be provided to players. Players should review the printed and video educational information posted on the qualifying webpage to prepare in advance for this process. Also, players should make sure their mobile devices are fully charged prior to beginning play.

PACE OF PLAY/UNREASONABLE DELAY (RULE 5.6): Players are expected to play without delay, and groups are expected to remain in position with the group immediately in front of it. Timing sheets for each round showing the time by when each hole must be completed are posted on the Qualifying webpage. Groups who fall out of position are subject to monitoring and timing by a rules official. Players are expected to play a stroke within 40 seconds of when it is their time to play. Players who receive a bad time will be warned. Players who receive multiple bad times are subject to penalty. The expected pace of play is **4:33** for 18 holes. Penalty for Breach of Rule 5.6a: **First breach:** *Warning;* **Second breach:** *One penalty stroke;* **Third breach:** *Two penalty strokes;* **Fourth breach:** *DISQUALIFICATION.*

COVID-19 SPECIAL CONDITIONS: Currently, the State of Minnesota has no limitations for COVID-19.

There are NO special COVID-19 rules pertaining to the Rules of Golf as dictated by the State.

PAPERWORK: Any and all paperwork (Local Rules Sheet, Hole Location Sheet, USGA Terms of Competition, etc.) will be available <u>ONLY</u> at the Qualifying webpage. No information will be available at the starting holes.

FOOTWEAR: Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition: DISQUALIFICATION.

GROOVES: The players' clubs <u>must conform</u> to the grooves and punch mark specifications in The Rules of Golf that are effective from January 1, 2010. Please refer to the USGA website for more detailed information.

DISTANCE MEASURING DEVICES: Per USGA Terms of Competition card and the Rules of Golf, distance measuring devices **ARE PERMITTED** in all stages of QUALIFYING. Please be sure any functionality that measures more than distance is disabled.

EVACUATION PLAN: In the event of a discontinuance of play during the qualifier, players must return to the Clubhouse for further instructions and updates.

PRACTICE ROUND AVAILABILITY: Bunker Hills Golf Course is extending their public rates for driving range, practice rounds and golf cart usage. Contact the host club for practice round starting times.

QUALIFYING ROUND FEES: There is no additional fee associated with the qualifying round.

CADDIES and CARTS: Bunker Hills Golf Course <u>will not</u> have caddies available. You may bring your own caddie if you wish to use one, or you may carry your own bag. Bunker Hills permits the use of push/pull carts. Per the USGA Junior Amateur Policy, a player may not use a parent, step parent, or legal guardian as a caddie during Sectional Qualifying or the Championship proper. A player is not required to employ a caddie for any stage of the Championship.

The use of motorized carts is prohibited during all phases of the Championship unless prior authorization is made through the USGA.

GOLF SHOP & PRACTICE AREAS: These areas will be open for player's use during the qualifying. Practice areas will open at least 60 minutes prior to the first starting time.

PERSONAL APPEARANCE: Contestants and caddies must be neat in appearance. The Committee will decide whether this requirement has been met. A caddie who does not meet the requirement will be asked to change or will not be permitted to caddie. The dress code applies to the caddies as well as the players. A player will be held responsible for the appearance of his caddie.

CARTS: Players must not ride on any form of transportation during a stipulated round unless authorized by the Committee.

SPECTATOR CARTS: Spectator carts will be available on a very limited basis. Persons interested in the use of a spectator cart must provide written proof of need and will be charged the applicable cart rate. Requests must go through **Bob Boldus**, the Official-in-Charge of the Qualifying. (see below)

FOOD SERVICE: <u>Food Service:</u> There will be limited food and beverage service available during the qualifying at the clubhouse as well as the Snack Shop adjacent to the 1st and 10th tees. Drinking water for contestants and caddies will be available on holes E4, E7, W4, W5, W9.

HOUSING/LODGING: No arrangements have been made for housing.
