REPAIR:

#1 Lift, Clean & Place within One Club Length anywhere in the General Area (does not have to stay in the same condition). #2 Once you finalize placing your ball under #1, you cannot touch it again. #3 If you are taking relief under another rule (such as immovable obstructions or penalty area), you are entitled to Lift, Clean & Place after taking relief.

EMBEDDED BALL: Rule 16.3 TEMPORARY WATER: Rule 16.1

1) Lightning (dangerous condition), one long horn blast, repeated. Stop Play IMMEDIATELY. SUSPENSION:

2) Other Reasons, Three (3) short horn blasts, repeated. 3) Resumption of Play, Two (2) short horn blasts, repeated.

SPOTS: Qualifiers: Alternates:

TIES: In the event of a tie for the last qualifying spot and/or the alternate spot, an on-course playoff will

commence immediately following the completion of play.

All play will be from the **Blue** tees (approx.: 6,600 yards).

RULES: The Rules of Golf, the MGA Terms of Competition, Pace of Play Policy and the following local rules

govern play. NOTE: Disregard any and all local rules printed on the local scorecard.

Two 9-hole rounds, stroke play. The MGA reserves the right to shorten the qualifying to 9 holes if, for any reason, the full 18 holes cannot be completed. If this happens, results will be based on 9-

hole scores with the available spots divided accordingly in the event of a two-tee start.

The official method of scoring will be electronic by use of the *Golf Genius Mobile App*. Paper scorecards will not be provided to players. Players should review the printed and video educational information posted on the qualifying webpage to prepare in advance for this process. Also, players

should make sure their mobile devices are fully charged prior to beginning play. After completing your final hole, please return to the scoring area to certify as the marker and as the

player.

OUT OF Course boundaries are defined by the following: White stake or lines and property

BOUNDS: fences. Inside edge of Pavement/Curbing for roads or parking lot bordering the course. The inside

edge of the silt fence marks the boundary.

PENALTY Penalty Areas are defined by either **RED** or **YELLOW** stakes and/or lines.

AREAS: When both stakes and lines are used to mark a Penalty Area, the stakes identify while the lines

define the Penalty Area.

DROPPING Local Rule E-1.1 Dropping Zones have been added as an additional option on holes: ZONE: #4 for a ball ending in the PA right of the fairway,

#6 for a ball ending in the PA behind the green,

#15 for a ball in the PA right of the fairway and in the Maintenance area, and

#17 for a ball in the PA right of the fairway.

In addition to areas circled by white lines, the following areas are *ground under repair:* **Model Local Rule F-7** – Ball in sod seams of newly sodded areas – *lie of ball only*

NO PLAY All cultivated flower & shrubbery beds - mandatory relief, no penalty ZONE:

OBSTRUCTIONS: All artificially surfaced roads and paths including gravel and rock surfaced paths and roads and

reasonable extensions thereof including their artificial borders. Buildings, sprinkler heads, vehicles, stakes, player equipment, signposts, benches, walls, and fences (not marking boundaries) are either

Moveable or Immovable Obstructions.
