Local Rules & Information

TEES: All play will be from the **Blue** tees (approx.: 6,122 yards). SPOTS: Qualifiers: Alternates:

TIES: In the event of a tie for the last qualifying spot and/or the alternate spot, an announcement will

be made as to the playoff procedure. Options may include an *on-course* playoff or scorecard

playoff.

**RULES:** The Rules of Golf, the MGA Terms of Competition, Pace of Play Policy, and the following local

rules govern play. NOTE: Disregard any and all local rules printed on the local scorecard.

**FORMAT:** Two 9-hole rounds, stroke play. The MGA reserves the right to shorten the qualifying to 9 holes

if, for any reason, the full 18 holes cannot be completed. If this happens, results will be based on

9-hole scores with the available spots divided accordingly in the event of a two-tee start.

**ELECTRONIC** The official method of scoring will be electronic by use of the *Golf Genius Mobile App*. Paper SCORING:

scorecards will not be provided to players. Players should review the printed and video

educational information posted on the qualifying webpage to prepare in advance for this process. Also, players should make sure their mobile devices are fully charged prior to beginning play. After completing your final hole, all players and their markers should go to the

Scoring Area immediately to certify their scores.

**OUT OF** Course boundaries are defined by the following:

**BOUNDS:** (1) White Stakes & Lines Northeast (2) Split Rail Fence on Right side of Holes #6, #7, and back of #9.

boundaries) are either Moveable or Immovable Obstructions.
