Options may include an *on-course* playoff or scorecard Mike Malone, playoff. **Ridges at Sand Creek RULES:** The Rules of Golf, the MGA Terms of Competition, Pace of Play Policy, and the following local rules govern play. NOTE: Disregard any and all local rules printed on the local scorecard. REGIONAL FORMAT: Two 9-hole rounds, stroke play. The MGA reserves the right to shorten the qualifying to 9 holes if, for any reason, the full 18 holes cannot be completed. If this happens, results will be based on VICE PRESIDENTS 9-hole scores with the available spots divided accordingly in the event of a two-tee start. Metro ELECTRONIC The official method of scoring will be electronic by use of the **Golf Genius Mobile App**. Paper Joe Conzemius. SCORING: scorecards will not be provided to players. Players should review the printed and video Interlachen Country Club educational information posted on the qualifying webpage to prepare in advance for this process. Also, players should make sure their mobile devices are fully charged prior to beginning play. Jenny Malek, After completing your final hole, all players and their markers should go to the Highland National Golf Club Scoring Area immediately to certify their scores. Northeast OUT OF Course boundaries are defined by the following: White stake or lines and property fences. Inside Mike Stone. BOUNDS: edge of Pavement/Curbing for roads or parking lot bordering the course. Crosswoods Golf Course Penalty Areas are defined by YELLOW or RED stakes and/or lines. PENALTY When both stakes and lines are used to mark a penalty area, the stakes *identify* the area, while AREAS: Northwest the lines *define* the edge of the penalty area. Glen Hasselberg.
