Local Rules and Information Sheet

TEES: Men will play from the **BLUE** tee markers
Senior Men will play from the **WHITE** tee markers
Women will play from the **GREEN** tee markers
Senior Women will play from the **GOLD** tee markers

FORMAT: 18 holes, Single and Four-Ball Match play. Singles matches are worth **one (1) point** each, and Four-Ball matches are worth **two (2) points** each. Any match ending **TIED** will be considered halved and the points are split. The first team to win 20½ points will claim the Matches. If the matches should end in a tie, the TEAM MINNESOTA PGA will retain the Cup.

RULES OF PLAY: All play is governed by the Rules of Golf, the MGA Rules Card, Notice to Competitors and the following local rules. NOTE: Disregard all local rules printed on the local scorecard.

HONOR/ORDER OF PLAY: The Four-Ball match takes precedence when determining the honor and order of play until the four-ball match concludes.

ADVICE: Players may continue to give advice to their teammate even if the Four-Ball match has concluded.

PRACTICE PUTTING: The prohibition of practice putting on the putting green of the hole last played has been waived for this competition.

OUT OF BOUNDS: In addition to white stakes, the following items define the boundaries:

- (1) Hole #1: Inside edge of netting poles for driving range,
- (2) Hole #2: Inside edge of parking lot curbing and
- (3) Hole #3: Opposite side of water when tied into white stakes.

PENALTY AREAS: If Penalty Areas are marked by lines and stakes, the stakes *identify* and the lines *define* the margin. If a penalty area is undefined, it will be by agreement of the players. If players cannot agree, it will be the decision of the match referee.

GROUND UNDER REPAIR: Areas circled with white lines. The mulched areas surrounding trees are not GUR but the mulch pieces are loose impediments. If there are questions regarding a ball in GUR, it will be decided by agreement of the players. If the players cannot agree, it will be the decision of the match referee.

NEWLY SODDED AREAS: Unless otherwise defined, interference from newly sodded areas is for lie of ball and area of intended swing only. No relief for interference for stance only.

IMMOVABLE OBSTRUCTIONS: The following are immovable obstructions: (1) Landscaped areas completely encircled by cart paths are part of the path,
(2) Stone pavers adjacent to a cart path are part of the path, and
(3) Boulders indicating 150 yards from the green (does not include the mulch)
